

QIA Agent Terms of Use

1. Scope

These Terms of Use («**Terms**») govern your access to and use of the AI Laboratory Assistant chatbot («**QIA Agent**») provided by QIAGEN GmbH, QIAGEN Str. 1, 40724 Hilden, Germany («**QIAGEN**», «**we**», «**us**») and embedded on its website <https://www.qiagen.com/> («**Website**»). By accessing or using QIA Agent, you acknowledge that you have read, understood, and accepted these Terms.

2. Permitted Use

You may use QIA Agent solely for its intended purposes. These purposes are to obtain general research-related experiment support, information about QIAGEN's products available on its Website, including general product-related information, product comparisons, and personalized recommendations based on your specific requirements. Where explicitly requested, QIA Agent may also provide direct links to relevant resources such as kit handbooks, display real-time stock availability, order status tracking, and support conversational buying by allowing you to add products directly to your cart within the chat interface.

QIA Agent is designed exclusively for information, internal research and support purposes. It is not intended to provide professional, legal, medical, or financial advice, nor is it meant to substitute scientific research. You acknowledge that QIA Agent generates responses using artificial intelligence and publicly available information. QIA Agent's responses or content may therefore be incomplete, inaccurate, outdated, or not applicable to your specific situation. As such, you should not rely solely on QIA Agent for making critical decisions and are responsible for independently verifying any important information received.
