Intended Use

The therascreen EGFR Pyro Kit is an *in vitro* nucleic acid sequence-based detection test based on Pyrosequencing[®] for the quantitative detection of mutations in exons 18, 19, 20, and 21 of the human EGFR gene in genomic DNA derived from human tissue samples.

The therascreen EGFR Pyro Kit is intended to provide clinicians with information to aid the selection of cancer patients more likely to benefit from treatment with anti-EGFR therapies. For in vitro diagnostic use.

For use only on the PyroMark® Q24 system. PyroMark Q24 systems include the following:

- The PyroMark Q24 instrument and the PyroMark Q24 MDx instrument.
- The PyroMark Q24 Vacuum Workstation and the PyroMark Q24 MDx Vacuum Workstation.
- PyroMark Q24 Software (version 2.0) and PyroMark Q24 MDx Software (version 2.0).

The product is intended to be used by professional users, such as technicians and physicians who are trained in in vitro diagnostics procedures, molecular biological techniques, and the PyroMark Q24 system.

Summary and Explanation

The therascreen EGFR Pyro Kit enables quantitative measurement of mutations in codons 719, 768, 790, and 858–861, as well as deletions and complex mutations in exon 19 of the human EGFR gene.




Figure 1. Illustration of the EGFR assay. The sequence indicated is the analyzed sequence for a wild-type sample. **FP**: Forward PCR primers; **RPB**: Reverse PCR primers (B indicates biotinylation); **Seq**: Sequencing primers.

The kit consists of four PCR assays (Figure 1) for the detection of:

- Mutations in codon 719 (exon 18)
- Mutations in codons 768 and 790 (exon 20)
- Mutations in codons 858 to 861 (exon 21)
- Deletions and complex mutations in exon 19

The four regions are amplified separately by PCR and sequenced through the defined region. The amplicon covering codons 768 and 790 is divided into two sequencing reactions. Sequences surrounding the defined positions serve as normalization and reference peaks for quantification and quality assessment of the analysis.

All assays are sequenced in the forward direction.

The product consists of a PCR primer mix and sequencing primers for each assay. The primers are delivered in solution. Each vial contains $24 \mu l$ of each primer or primer mix.

Principle of the Procedure

The workflow below illustrates the assay procedure. After PCR using primers targeting exons 18, 19, 20, and 21, the amplicons are immobilized on Streptavidin Sepharose® High Performance beads. Single-stranded DNA is prepared and the corresponding sequencing primers anneal to the DNA. The samples are then analyzed on the PyroMark Q24 system using a run setup file and a run file.


It is recommended to use the EGFR Plug-in Report to analyze the run. The EGFR Plug-in Report can be obtained by e-mail from pyro.plugin@qiagen.com.

However, the run can also be analyzed using the analysis tool integral to the PyroMark Q24 system. The "Sequence to Analyze" can then be adjusted for

detection of different deletions in exon 19 and of rare mutations in the other exons after the run (see "Protocol 6: Analysis of a PyroMark Q24 run", page 28).

Note: The workflow has been slightly modified compared to revision R1 of the therascreen *EGFR Pyro Kit Handbook* (see "Protocol 4: Preparation of samples prior to Pyrosequencing analysis on the PyroMark Q24", page 22).

Workflow of therascreen EGFR Pyro procedure



Controls

Unmethylated control DNA is included in the kit as a positive control for PCR and sequencing reactions. This control DNA has a wild-type genotype in the regions sequenced using this kit and is required for adequate result interpretation and identification of low-level mutations (see "Interpretation of Results", page 31). Include a sample with unmethylated control DNA for each assay in every Pyrosequencing run.

In addition, a negative control (without template DNA) should be included in every PCR setup for at least one assay.

General precautions

Note: The user should always pay attention to the following.

- Strict compliance with the user manual is required for optimal results. Dilution of the reagents, other than as described in this handbook, is not recommended, and will result in a loss of performance.
- The workflow has been slightly modified (see "Protocol 4: Preparation of samples prior to Pyrosequencing analysis on the PyroMark Q24", page 22) compared to revision R1 of the therascreen EGFR Pyro Kit Handbook.
- The components of this product are sufficient to perform 24 reactions in up to 5 independent runs.
- Use sterile pipet tips with filters (for PCR setup).

- Store and extract positive materials (specimens, positive controls, and amplicons) separately from all other reagents and add them to the reaction mix in a spatially separated facility.
- Thaw all components thoroughly at room temperature (15–25°C) before starting an assay.
- When thawed, mix the components (by pipetting repeatedly up and down or by pulse vortexing) and centrifuge briefly.
- Failed results are not a basis for judgment of mutational status.

Reagent Storage and Handling

The therascreen EGFR Pyro Kit is shipped in two boxes. The therascreen EGFR Pyro Kit (box 1/2) is shipped on dry ice. PyroMark PCR Master Mix, CoralLoad Concentrate, unmethylated control DNA, and all primers should be stored at -30°C to -15°C upon arrival.

The therascreen buffers and reagents (box 2/2) containing buffers, enzyme mixture, substrate mixture, dATP α S, dCTP, dGTP, and dTTP (the reagents for Pyrosequencing® analysis) are shipped on cool packs. These components should be stored at 2-8°C upon arrival. To minimize loss of activity, it is advisable to keep both the enzyme mixture and the substrate mixture in the vials supplied.

Reconstituted enzyme and substrate mixtures are stable for at least 10 days at 2–8°C. Reconstituted enzyme and substrate mixtures can be frozen and stored in their vials at –30°C to –15°C. Frozen reagents should not be subjected to more than 3 freeze–thaw cycles.

Note: Nucleotides should not be frozen.

The therascreen EGFR Pyro Kit is stable until the kit expiration date when stored under these conditions.

Specimen Handling and Storage

All samples must be treated as potentially infectious material.

Specimen material is human DNA extracted from blood or formalin-fixed paraffin-embedded (FFPE) samples.

Samples from humans undergoing heparin treatment must not be used. Blood samples that have been collected in tubes containing heparin as an anticoagulant should not be used. Heparin affects the PCR.

Procedure

DNA isolation

The system performance has been established using the EZ1® DNA Tissue Kit and the QIAamp® DNA FFPE Tissue Kit for extraction of human DNA from formalin-fixed paraffin-embedded tumor samples. For the QIAamp DSP DNA Blood Mini Kit system, performance has been established using healthy donor blood samples partially spiked with tumor cells.

The QIAGEN® kits shown in Table 2 are recommended for DNA purification from the indicated human sample types for use with the *therascreen* EGFR Pyro Kit. Carry out the DNA purification according to the instructions in the kit handbooks.

Protocol 1: Run setup for the PyroMark Q24 system

Important point before starting

If required, the LOB can be confirmed by using a wild-type sample to generate a full plate of results. For details, consult CLSI Guideline EP17-A "Protocol for determination of limits of detection and limits of quantitation; approved guideline".

Things to do before starting

If the EGFR Plug-in Report has not been installed, create an Assay Setup (see Appendix A, page 51). This must only be done once before running the therascreen EGFR Pyro assays for the first time. In case the EGFR Plug-in Report has been installed, predefined Assay Setups are available in the shortcut browser of the PyroMark Q24 software under the path "Example Files/PyroMark Setups/EGFR". The EGFR Plug-in Report can be obtained by e-mail from pyro.plugin@giagen.com.

Procedure

1. Click **1** in the toolbar.

A new run file is created.

- 2. Enter the run parameters (see "Run parameters", page 16).
- 3. Set up the plate by adding assays for the 5 different sequencing reactions to wells corresponding to the samples to analyze.

Note: A negative control sample (without template DNA) should be included in every PCR setup for at least one assay.

Note: Include a sample with unmethylated control DNA for each assay in every Pyrosequencing run (see "Controls", page 11).

- 5. Close the run file and copy it to a USB stick (supplied with the system) using Windows® Explorer.

Note: The printed Pre Run Information can be used as a template for the sample set up (see "Protocol 3: Immobilization of PCR products to Streptavidin Sepharose High Performance beads", page 20).

To run the plate on PyroMark Q24, see "Protocol 5: Running the PyroMark Q24", page 26.

Run parameters

Run name: The name of the run is given when the file is saved.

Renaming the file also changes the name of the run.

Instrument method: Select the instrument method according to the

cartridge that will be used for the run. See the

instructions supplied with the products.

Plate ID: Optional: Enter ID of the PyroMark Q24 Plate.

Bar code: Optional: Enter a bar code number for the plate or, if

you have a bar code reader connected to your computer, place the mouse cursor in the "Barcode" text box (by clicking the box) and scan the bar code.

Kit and Reagent ID: Optional: Enter the lot number for the therascreen

EGFR Pyro Kit to be used. The lot number can be

found on the product label.

Note: We recommend entering both the reagent ID and the kit ID so that any unexpected problems with

the reagents can be traced.

Run note: Optional: Enter a note about the contents or purpose

of the run.

Add assay files

To add an assay to a well, you can either:

- Right-click the well and select "Load Assay" from the context menu.
- Select the assay in the shortcut browser, and click and drag the assay to the well.

A well is color-coded according to the assay loaded to the well.

Enter sample IDs and notes

To enter a sample ID or note, select the cell and enter the text.

To edit a sample ID or note, either select the cell (the current contents will be selected) or double-click the cell.

Protocol 2: PCR using the PCR reagents supplied with the therascreen EGFR Pyro Kit

This protocol is for 4 separate PCR amplifications of regions containing codon 719 (exon 18), codons 768 and 790 (exon 20), codons 858–861 (exon 21), or deletions and complex mutations in exon 19 using the *therascreen* EGFR Pyro primers.

Important points before starting

- The HotStarTaq[®] DNA polymerase in the PyroMark Master Mix requires an activation step of **15 minutes at 95°C**.
- Set up all reaction mixtures in an area separate from that used for DNA purification, adding template DNA to the PCR, PCR product analysis, or preparation of samples prior to Pyrosequencing analysis.
- Use disposable tips containing hydrophobic filters to minimize cross-contamination.

Things to do before starting

- Before opening the tubes with PCR primers, centrifuge briefly to collect contents at the bottom of the tubes.
- Adjust the concentration of the control and sample DNA to 0.4–2 $ng/\mu l$, if necessary.

Procedure

Thaw all necessary components (see Table 3).
 Mix well before use.

2. Prepare a reaction mix for each PCR primer set according to Table 3.

The reaction mix typically contains all of the components needed for PCR except the sample.

Prepare a volume of reaction mix greater than that required for the total number of PCR assays to be performed.

3. Mix the reaction mix thoroughly and dispense 20 μ l into each PCR tube.

It is not necessary to keep PCR tubes on ice since HotStarTaq DNA Polymerase is inactive at room temperature.

4. Add 5 μ l template DNA (2–10 ng of genomic DNA) to the individual PCR tubes (see Table 4) and mix thoroughly.

Note: A negative control sample (without template DNA) should be included in every PCR setup for at least one assay.

Note: Include a sample with unmethylated control DNA for each assay in every Pyrosequencing run (see "Controls", page 7).

5. Program the thermal cycler according to the manufacturer's instructions, using the conditions outlined in Table 5.

- 6. Place the PCR tubes in the thermal cycler and start the cycling program.
- 7. After amplification, proceed with "Protocol 3: Immobilization of PCR products to Streptavidin Sepharose High Performance beads", page 20.

Protocol 3: Immobilization of PCR products to Streptavidin Sepharose High Performance beads

This protocol is for immobilization of template DNA to Streptavidin Sepharose High Performance (GE Healthcare) prior to analysis on the PyroMark Q24 system.

Things to do before starting

Allow all required reagents and solutions to reach room temperature (15–25°C) before starting.

Procedure

- 1. Gently shake the bottle containing Streptavidin Sepharose High Performance until it is a homogeneous solution.
- 2. Prepare a master mix for DNA immobilization according to Table 6. Prepare a volume 10% greater than that required for the total number of reactions to be performed.

- 3. Add 70 μ l of the master mix to wells of a 24-well PCR plate or strips as predefined in the run setup (see "Protocol 1: Run setup for the PyroMark Q24 system", page 15).
- 4. Add 10 μ l of biotinylated PCR product from Protocol 2 to each well containing master mix as predefined in the run setup (see "Protocol 1: Run setup for the PyroMark Q24 system", page 15).

Note: The total volume per well should be 80 μ l after addition of the master mix and PCR product.

5. Seal the PCR plate (or strips) using strip caps.

Note: Ensure that no leakage is possible between the wells.

6. Agitate the PCR plate at room temperature (15–25°C) for 5–10 minutes at 1400 rpm.

Note: During this step, prepare the PyroMark Q24 Vacuum Workstation for sample preparation as described in the *PyroMark Q24 User Manual*.

7. Proceed immediately with "Protocol 4: Preparation of samples prior to Pyrosequencing analysis on the PyroMark Q24", page 22.

Note: Sepharose beads sediment quickly. Capturing of the beads must take place immediately following agitation.

If more than 1 minute has elapsed since the plate (or strips) was agitated, agitate again for 1 minute before capturing the beads.

Protocol 4: Preparation of samples prior to Pyrosequencing analysis on the PyroMark Q24

This protocol is for preparation of single-stranded DNA and annealing of the sequencing primer to the template prior to Pyrosequencing analysis on the PyroMark Q24.

Important points before starting

- Before opening the tubes with sequencing primers, centrifuge briefly to collect contents at the bottom of the tubes.
- Add the 5 different sequencing primers in the same pattern as predefined for the plate in the run setup (see "Protocol 1: Run setup for the PyroMark Q24 system", page 15), depending on the region of analysis (codon 719 [exon 18], codons 768 and 790 [exon 20], codons 858–861 [exon 21], or exon 19).
- The workflow has been slightly modified compared to revision R1 of the therascreen EGFR Pyro Kit Handbook (step 18). Do not shorten the time for cooling down the samples after heating to 80°C.
- Perform the function test for filter probes as described in the *PyroMark Q24* User Manual on a regular basis and exchange filter probes when indicated.

Things to do before starting

- Place one PyroMark Q24 Plate Holder on a preheated heating block at 80°C for use in step 17. Leave a second PyroMark Q24 Plate Holder at room temperature (15–25°C) for use in step 18.
- PyroMark Wash Buffer is supplied as a 10x concentrate. Before using for the first time, dilute to a 1x working solution by adding 225 ml high-purity water to 25 ml 10x PyroMark Wash Buffer (final volume of 250 ml).

Note: The 1x PyroMark Wash Buffer working solution is stable at 2–8°C until the marked expiration date.

Procedure

1. Dilute a sufficient amount of each sequencing primer (Seq Primer EGFR 719, Seq Primer EGFR 768, Seq Primer EGFR 790, Seq Primer EGFR 858–861, and Seq Primer EGFR Exon 19 Del) in PyroMark Annealing Buffer as shown in Table 7.

Prepare a volume of diluted sequencing primer greater than that required for the total number of samples to be sequenced (for the number of samples + one extra).

2. Add 25 μ l of diluted sequencing primer to each well of the PyroMark Q24 Plate according to the run setup (see "Protocol 1: Run setup for the PyroMark Q24 system", page 15).

Note: Keep one of the PyroMark Q24 Plate Holders (supplied with the PyroMark Q24 Vacuum Workstation) at room temperature (15–25°C) and use it as support when preparing and moving the plate.

3. Place the PCR plate (or strips) from Protocol 3 and the PyroMark Q24 Plate on the worktable (Figure 2).

Note: Ensure that the plate is in the same orientation as when samples were loaded.



Figure 2. Placement of PCR plate (or strips) and PyroMark Q24 plate on the vacuum workstation.

- 4. Apply vacuum to the tool by switching on the vacuum.
- 5. Carefully lower the filter probes of the vacuum tool into the PCR plate (or strips) to capture the beads containing immobilized template. Hold the probes in place for 15 seconds. Take care when picking up the vacuum tool.

Note: Sepharose beads sediment quickly. Capturing of the beads must take place immediately following agitation.

If more than 1 minute has elapsed since the plate (or strips) was agitated, agitate again for 1 minute before capturing the beads.

- 6. Transfer the vacuum tool to the trough containing 40 ml 70% ethanol (Figure 2). Flush the filter probes for 5 seconds.
- 7. Transfer the vacuum tool to the trough containing 40 ml Denaturation Solution (Figure 2). Flush the filter probes for 5 seconds.
- 8. Transfer the vacuum tool to the trough containing 50 ml Wash Buffer (Figure 2). Flush the filter probes for 10 seconds.
- 9. Raise the vacuum tool up and back, beyond 90° vertical, for 5 seconds to drain liquid from the filter probes (Figure 3).



Figure 3. Illustration of the vacuum tool raised to beyond 90° vertical.

- 10. While the vacuum tool is held over the PyroMark Q24 Plate, close the vacuum switch on the tool (Off).
- 11. Release the beads in the PyroMark Q24 Plate by lowering the filter probes into the diluted sequencing primer and moving the tool gently from side to side.

Note: Take care not to damage the surface of the PyroMark Q24 Plate by scratching it with the filter probes.

- 12. Transfer the vacuum tool to the trough containing high-purity water (Figure 2) and agitate it for 10 seconds.
- 13. Wash the filter probes by lowering the probes into high-purity water (Figure 2) and applying vacuum. Flush the probes with 70 ml high-purity water.

- 14. Raise the vacuum tool up and back, beyond 90° vertical, for 5 seconds to drain liquid from the filter probes (Figure 3).
- 15. Close the vacuum switch on the tool (Off), and place the vacuum tool in the Parking (P) position.
- 16. Turn off the vacuum pump.

Note: At the end of a working day, liquid waste and remaining solutions should be discarded and the PyroMark Q24 Vacuum Workstation should be checked for dust and spillage (see Appendix B, page 55).

- 17. Heat the PyroMark Q24 Plate with the samples at 80°C for 2 minutes using the prewarmed PyroMark Q24 Plate Holder.
- 18. Remove the PyroMark Q24 Plate from the hot plate holder and place xit on a second PyroMark Q24 Plate Holder that was kept at room temperature (15–25°C) to let the samples cool to room temperature for 10–15 minutes.
- 19. Proceed with "Protocol 5: Running the PyroMark Q24", page 26.

Protocol 5: Running the PyroMark Q24

This protocol describes the preparation and loading of PyroMark Gold Q24 reagents into the PyroMark Q24 Cartridge and starting and finishing a run on the PyroMark Q24. For a detailed description about how to set up a run, see the PyroMark Q24 User Manual.

Important point before starting

The Pre Run information report, found in the "Tools" menu at run setup (see "Protocol 1: Run setup for the PyroMark Q24 system", page 15), provides information about the volume of nucleotides, enzyme, and substrate buffer needed for a specific run.

Things to do before starting

Switch on the PyroMark Q24. The power switch is located at the rear of the instrument.

Procedure

- 1. Dissolve the freeze-dried enzyme and substrate mixtures in 620 μ l each of water (H₂O, supplied).
- 2. Mix by swirling the vial gently.

Note: Do not vortex!

Note: In order to ensure that the mixture is fully dissolved, leave it at room temperature (15–25°C) for 5–10 minutes. Make sure that the solution is not turbid before filling the PyroMark Q24 Cartridge. If the reagents are not to be used immediately, place the reagent vials on ice* or in a refrigerator.

- 3. Allow the reagents and the PyroMark Q24 Cartridge to reach ambient temperature (20–25°C).
- 4. Place the PyroMark Q24 Cartridge with the label facing you.




Figure 4. Illustration of the PyroMark Q24 Cartridge as seen from above. The annotations correspond to the label on the reagent vials. Add enzyme mixture (**E**), substrate mixture (**S**), and nucleotides (**A**, **T**, **C**, **G**) according to the volume information given in the Pre Run information report, found in the "Tools" menu at run setup.

- 5. Load the PyroMark Q24 Cartridge with the appropriate volumes of nucleotides, enzyme, and substrate mixes according to Figure 4.
 Make sure that no air bubbles are transferred from the pipet to the cartridge.

^{*} When working with chemicals, always wear a suitable lab coat, disposable gloves, and protective goggles. For more information, consult the appropriate safety data sheets (SDSs), available from the product supplier.

- 6. Open the cartridge gate and insert the filled reagent cartridge with the label facing out. Push the cartridge in fully and then push it down.
- 7. Ensure the line is visible in front of the cartridge and close the gate.
- 8. Open the plate-holding frame and place the plate on the heating block.
- 9. Close the plate-holding frame and the instrument lid.
- 10. Insert the USB stick (containing the run file) into the USB port at the front of the instrument.

Note: Do not remove the USB stick before the run is finished.

- 11. Select "Run" in the main menu (using the ▲ and ▼ screen buttons) and press "OK".
- 12. Select the run file using the ▲ and ▼ screen buttons.

Note: To view the contents of a folder, select the folder and press "Select". To go back to the previous view, press "Back".

- 13. When the run file is selected, press "Select" to start the run.
- 14. When the run is finished and the instrument confirms that the run file has been saved to the USB stick, press "Close".
- 15. Remove the USB stick.
- 16. Open the instrument lid.
- 17. Open the cartridge gate and remove the reagent cartridge by lifting it up and pulling it out.
- 18. Close the gate.
- 19. Open the plate-holding frame and remove the plate from the heating block.
- 20. Close the plate-holding frame and the instrument lid.
- 21. Discard the plate and clean the cartridge as per the instructions in the product sheet supplied with the cartridge.
- 22. Analyze the run according to "Protocol 6: Analysis of a PyroMark Q24 run", page 28.

Protocol 6: Analysis of a PyroMark Q24 run

This protocol describes the mutation analysis of a finished EGFR run using PyroMark Q24 Software.

Procedure

- 1. Insert the USB stick containing the processed run file into the computer's USB port.
- 2. Move the run file from the USB stick to the desired location on the computer using Windows Explorer.
- 3. Open the run file in the AQ mode of PyroMark Q24 Software either by selecting "Open" in the "File" menu or by double-clicking the file (v) in the shortcut browser.
- 4. There are 2 methods for analyzing the run. If using the EGFR Plug-in Report, go to step 5. If using the AQ analysis integral to the PyroMark Q24, go to step 6.

Note: We strongly recommend using the EGFR Plug-in Report for result interpretation. The EGFR Plug-in Report can be obtained by e-mail from pyro.plugin@qiagen.com. This report ensures that the respective LOD values and different "Sequences to Analyze" are used to automatically detect all mutations and deletions, including the identification of twenty different deletions and complex mutations in Exon 19.

5. Using the EGFR Plug-in Report:




Figure 5. The AQ Run Analysis screen.

Select "AQ Add On Reports/EGFR and "Exon 18 Codon 719" or "Exon 19 Deletions" or "Exon 20 Codon 768" or "Exon 20 Codon 790" or "Exon 21 Codons 858 to 961" from "Reports" in the menu (Figure 5).

The wells will automatically be analyzed for all mutations for which the LOD is given in Table 8. The results will be presented in an overview table (Figure 6), followed by the detailed results which include Pyrograms and analysis quality.

6. Using AQ analysis:

To analyze the EGFR run and get an overview of the results, click one of the Analyze buttons.

Analyze all wells.

Analyze the selected well.

The analysis results (allele frequencies) and quality assessment are displayed above the variable position in the Pyrogram[®] trace. For more details on how to analyze a run see the *PyroMark Q24 User Manual*.

To generate a report, select "AQ Full Report" or "AQ Analysis Results" in the "Reports" menu.

Note: The standard "Sequence to Analyze" as defined in the Analysis Setup addresses the most frequent mutations in codons 719, 768, 790, 858, and 861 and the most frequent deletion in exon 19 (see Appendix A, page 51). If a sample contains a less frequent mutation, the "Sequence to Analyze" can be changed to analyze also the mutation status at this position, as described in Appendix A.

Updated frequencies of mutations in the human EGFR gene are provided online by the Sanger Institute at www.sanger.ac.uk/genetics/CGP/cosmic/.

Note: For reliable results, we recommend single peak heights above 20 RLU for the codon 768 assay and above 30 RLU for the remaining four assays. Set 20 or 30 RLU, respectively, as the "required peak height for passed quality" in assay setup (see the *PyroMark Q24 User Manual* and Appendix A).

Note: To allow proper quantification for codon 719 and codon 790, adjust the heights of the histogram bars in the assay setup (see Appendix A, page 51).

Note: The "AQ Analysis Results" report should be used for documentation and interpretation of allele quantification. The numbers shown in the Pyrogram are rounded and do not show the exact quantification.

Note: The Pyrogram should always be compared to the histogram, which can be displayed by right-clicking in the Pyrogram window. The measured peaks should match the height of the histogram bars.

Reanalysis of samples with no mutation detected with standard "Sequence to Analyze" or with "Check" or "Failed" quality assessment

We strongly recommend reanalyzing all samples with no mutation detected with the standard "Sequence to Analyze", as well as samples that received "Check" or "Failed" quality assessment. "Check" and "Failed" quality assessments may indicate a mutation in another position resulting in unexpected reference peaks.

To reanalyze and target less frequent mutations go to "Analysis Setup" and change "Sequence to Analyze" to variants described in Appendix A or variants for other rare or unexpected mutations. Click "Apply", and then click "To All" when the "Apply Analysis Setup" window appears.

Note: After changing "Sequence to Analyze", ensure the threshold for single peak height and the height of histogram bars are adjusted accordingly (see Appendix A, page 51).

Note: If the measured peaks do not match the height of the histogram bars and cannot be explained by rare or unexpected mutations, the result is not a basis for judgment of mutational status. It is recommended to rerun the sample.

Interpretation of Results

Interpretation of analysis results and detection of low-level mutations

It is strongly recommended that unmethylated control DNA is included in every run for comparison and as a control for background levels. The measured frequency of the control sample should be smaller or equal to the limit of blank (LOB).

All samples should be examined in relation to the limit of detection (LOD, see Table 8) and interpreted as follows.

- Mutation frequency < LOD: Wild type</p>
- Mutation frequency \geq LOD and \leq LOD + 3 % units: Potential low-level mutation

Note: If using the Plug-in Report (see step 5 of "Protocol 6: Analysis of a PyroMark Q24 run", page 28) and this occurs, a warning will be issued.

Samples with a reported potential low-level mutation should only be considered positive for the mutation if confirmed by rerunning in duplicate together with a sample with unmethylated control DNA. The result of both duplicates should be \geq LOD and different from the control sample. Otherwise the sample should be judged as wild type.

■ Mutation frequency > LOD + 3 % units: Mutation

If using the EGFR Plug-in Report, this is performed automatically.

Note: It is recommended to use the EGFR Plug-in Report for result interpretation. For closer examination of samples with a reported potential low-level mutation, we recommend to additionally analyze the sample manually in the application software (e.g., for comparison to the mutational frequency of the control sample).

Note: A measured frequency above LOB in the control sample indicates a higher than usual level of background in the respective run, which might impact allele quantification, especially for low mutational levels. In this case, measured frequencies in the range from LOD (Table 8) to LOD + 3 % units are not a basis for judgment of mutational status. It is recommended to rerun samples with a potential low-level mutation.

Note: A treatment decision for cancer patients must not be based solely on EGFR mutation status.




Figure 7. Pyrogram trace obtained after analysis of a sample with a wild-type genotype in codon 719 with the "Sequence to Analyze" DGCTCCGGTGC.




Figure 8. Pyrogram trace obtained after analysis of a sample with a wild-type genotype in codon 768 with the "Sequence to Analyze" CAKCGTG.




Figure 9. Pyrogram trace obtained after analysis of a sample with a wild-type genotype in codon 790 with the "Sequence to Analyze" ATCAYGCAG.




Figure 10. Pyrogram trace obtained after analysis of a sample with a wild-type genotype in codons 858–861 with the "Sequence to Analyze" CKGGCCAAACDGCTGGGT.




Figure 11. Pyrogram trace obtained after analysis of a sample with a wild-type genotype in exon 19.




Figure 12. Pyrogram trace obtained after analysis of a sample with an ACG \rightarrow ATG mutation in base 2 of codon 790 (indicated with an arrow).




Figure 13. Pyrogram trace obtained after analysis of a sample with a CTG \rightarrow CGG mutation in base 2 of codon 858 (indicated with an arrow).




Figure 14. Pyrogram trace obtained after analysis of a sample with a 2235del15 deletion in exon 19.

Troubleshooting guide

This troubleshooting guide may be helpful in solving any problems that may arise. Note: Refer to the *PyroMark Q24 User Manual* for general troubleshooting of the instrument.

Comments and suggestions

Signals in the no template control (negative control)

a) Cross-talk between Signal from one well is detected in a neighboring wells well. Avoid placing samples with high signal intensities next to no template control wells.

b) PCR contamination

Use sterile pipet tips with filters. Store and extract materials such as specimens, controls, and amplicons separately from PCR reagents.

Comments and suggestions

Poor or unexpected sequence

a) Low quality genomic DNA

Low quality genomic DNA can cause the PCR to fail. Analyze PCR samples using an electrophoretic technique (for example, the QIAxcel[®] System or agarose-gel electrophoresis).

"Check" or "failed" result

a) Low peak height

Handling errors in PCR setup or sample preparation prior to Pyrosequencing can result in low peaks. Perform the function test for filter probes as described in the *PyroMark Q24 User Manual* on a regular basis and exchange filter probes when indicated.

In case of a "Check" warning carefully compare the Pyrogram to the histogram which can be displayed by a right click in the Pyrogram window. If the measured peaks match the height of the histogram bars, the result is valid. Otherwise, it is recommended to rerun the sample.

b) Mutation not defined in "Sequence to Analyze" Adjust the "Sequence to Analyze" in the assay setup (see Appendix A, page 51) and reanalyze the run.

c) Unexpected rare mutation

A "Check" or "Failed" quality assessment can be caused by an unexpected pattern of peaks. This might indicate an unexpected mutation which is not analyzed by the provided "Sequences to Analyze". These samples should be analyzed using the alternative "Sequences to Analyze" considering unexpected mutations.

 d) High peak height deviation warning at dispensation x The Pyrogram should be carefully compared to the histogram, which can be displayed by a right click in the Pyrogram window. In case the measured peaks do not match the height of the histogram bars and cannot be explained by rare mutations, it is recommended to rerun the sample.

Comments and suggestions

d) Warning message

Background noise at dispensation T8 is below expected level. Adjust the height of the histogram bar to the default value (1.00, only possible when using the analysis tool integral to the PyroMark Q24 Software).

e) Warning message

dispensation: 10."
appears in the codon
858-861 assay.

A high level CTG>CGG mutation in codon 858 (L858R) can result in increased background in dispensations G-10 and A-12 and a frequency above LOD for the mutation ATG>CAG in codon 861 (L861Q). In this case, only the reported L585R mutation is valid and the warning and "Check" quality can be disregarded.

Note: The EGFR Plug-in Report will report only one mutation (i.e., the mutation with the highest frequency).

f) Warning message
"Uncertain due to high
peak height deviation
at dispensation: 23."
appears when the
2235del15 deletion is
reported.

A high level 2235del15 deletion can result in this warning. In this case, the reported mutation is valid and the warning and "Check" quality can be disregarded.

High background

- a) Incorrect storage of nucleotides
- Store nucleotides at 2–8°C. Storage at –15 to –25°C can cause an increase in the background.
- b) Short cooling time of samples prior to Pyrosequencing analysis
- Keep the samples on a PyroMark Q24 plate holder at room temperature for 10–15 minutes. Do not shorten the cooling time.
- c) Contamination of cartridge

Carefully clean the cartridge as described in the product sheet. Store the cartridge protected from light and dust.

Comments and suggestions

No signals in positive control (unmethylated control DNA)

 a) Insufficient enzyme or substrate mix for all wells Make sure to fill the PyroMark Q24 Cartridge according to the "Pre Run Information" in the "Tools" menu.

b) Reagents incorrectly stored or diluted

Prepare the *therascreen* reagents according to the instructions in "Protocol 5: Running the PyroMark Q24", page 26.

c) PCR or sample preparation failure

Handling errors in PCR setup, programming of the PCR cycler, or sample preparation prior to Pyrosequencing can result in no signals. Perform the function test for filter probes as described in the PyroMark Q24 User Manual and exchange filter probes when indicated. Repeat the PCR and Pyrosequencing analysis.

Quality Control

In accordance with QIAGEN's ISO-certified Quality Management System, each lot of the *therascreen* EGFR Pyro Kit is tested against predetermined specifications to ensure consistent product quality.

Limitations

Any diagnostic results generated must be interpreted in conjunction with other clinical or laboratory findings.

It is the user's responsibility to validate system performance for any procedures used in their laboratory which are not covered by the QIAGEN performance studies.

Performance Characteristics

Limit of blank and limit of detection

The limit of blank (LOB) and limit of detection (LOD) have been determined for a number of mutations using mixtures of plasmids (Table 9). LOB and LOD were determined according to the recommendations in the Clinical and Laboratory Standards Institute (CLSI) Guideline EP17-A "Protocol for determination of limits of detection and limits of quantitation; approved guideline". α - and β -errors (false positive and false negative, respectively) were set to 5%. LOD for some rare deletions in Exon 19 were determined by adding six standard deviations of blank measurements to the LOB value.

LOB values represent the measured frequency obtained with a wild-type sample. LOD values represent the lowest signal (measured frequency) that can be regarded as positive for the respective mutation.

The mutation CTG → CGG in codon 858

For the CTG \rightarrow CGG mutation in codon 858, the measurements of samples with low levels of mutation had a non-Gaussian distribution. LOD was therefore determined using a different method, according to the recommendations in the CLSI Guideline EP17-A. The lowest signal that indicates the presence of a mutation (LOD) in these positions was set to 2 % units above the respective baseline level as defined by the 95th percentile of blank measurements. When analyzing a sample with a mutation level of 5.5%, 95% of results (n=72) gave a signal that can be regarded as positive (\geq LOD, i.e., \geq 2.6 % units).

Linearity

Linearity was determined using mixtures of plasmids carrying the wild-type or mutant sequence for the mutations GGC>AGC codon 719, ACG>ATG in codon 790, CTG>CGG in codon 858, and the deletions 2235del15 and 2236del15 in Exon 19. The plasmids were mixed in proportions to give four levels of mutation (5, 10, 30, and 50%). Each mixture was analyzed with three different lots of the *therascreen* EGFR Pyro Kit in three Pyrosequencing runs with three replicates each.




Figure 15. Linearity of deletion 2235del15 in Exon 19.

The results (n=9 for each mutation level) were analyzed according to the CLSI Guideline EP6-A "Evaluation of the linearity of quantitative measurement procedures: a statistical approach; approved guideline" using the Analyse-it® Software v2.21 and are shown in Figure 15 for the deletion 2235del15 in Exon 19.

The results were linear within an allowable nonlinearity of 5 % units in the tested range of 5 to 50% mutation level. Similar results were obtained for the mutations GGC>AGC in codon 719, ACG>ATG in codon 790, CTG>CGG in codon 858, and the deletion 2236del15 in Exon 19.

Precision

The precision data allows the determination of the total variability of the assays and was obtained at three different levels by analysis of the above mentioned plasmid mixtures with three replicates each.

Repeatability (intra-assay and inter-batch variability) was calculated based on the data for determination of linearity (three runs on the same day using varying lots of the *therascreen* EGFR Pyro Kit). Intermediate precision (intra-laboratory variability) was determined in three runs within one laboratory on three different days with varying operators, PyroMark Q24 instruments, and lots of the *therascreen* EGFR Pyro Kit. Reproducibility (inter-laboratory variability) was calculated from two runs each in an internal and external laboratory and using varying lots of the *therascreen* EGFR Pyro Kit.

Precision estimates are expressed as standard deviation of the measured mutation frequencies in % units (Table 10). The repeatability, intermediate precision, and reproducibility for the deletion 2235del15 in exon 19 was 0.8–1.2, 0.7–2.9, and 0.7–1.8 % units, respectively, in the measured range of 5 to 50% mutation level. Similar results were obtained for the mutations GGC>AGC in codon 719, ACG>ATG in codon 790, CTG>CGG in codon 858, and the deletion 2236del15 in exon 19.

Diagnostic evaluation

The therascreen EGFR Pyro Kit was evaluated in comparison with Sanger sequencing and the therascreen EGFR RGQ Kit. DNA was extracted from 100 formalin-fixed paraffin-embedded (FFPE) tumor samples from non-small cell lung cancer (NSCLC) and analyzed for mutations in codons 719, 768, 790, and 858–861, and deletions and complex mutations in exon 19.

DNA was isolated using the QIAamp DNA FFPE Tissue Kit. Analyses were carried out with the *therascreen* EGFR Pyro Kit on the PyroMark Q24, with the *therascreen* EGFR RGQ Kit on the Rotor Gene-Q 5plex HRM series II and Sanger sequencing was carried out on the ABI® 3130 Genetic Analyzer.

Of 100 samples analyzed the mutational status could be determined for all codons and exon 19 in 97 samples with all three methods. For two samples the mutational status of codon 768 could not be determined by Pyrosequencing, and one sample failed for most of the codons with all three methods, indicating the DNA quality was too low to allow amplification.

The T790M resistance mutation was detected in one sample with all three methods while the L861Q mutation was detected in one sample only by Pyrosequencing. Thirteen, twelve, and sixteen deletions and complex mutations in exon 19 were detected by Pyrosequencing, Rotor-Gene Q, and Sanger sequencing analysis, respectively. Three of the exon 19 deletions detected by Sanger sequencing could not be reproduced by both Pyrosequencing and Rotor-Gene Q analysis. The L858R mutation was detected in three samples by all three methods, in two samples by Pyrosequencing and either one of the other methods, in one sample by Pyrosequencing only, and in one sample by Rotor-Gene Q analysis only. The results are illustrated in Tables 11–14.

No mutations were detected in codons 719 and 768 in the 100 samples by any of the three methods.

Excluding samples that failed in one or more methods, the *therascreen* EGFR Pyro Kit and Sanger sequencing showed 100%, 98%, 99%, and 97% concordance in results for the codons 790, 858, 861, and exon 19, respectively, while the *therascreen* EGFR Pyro Kit and *therascreen* EGFR RGQ Kit showed 100%, 97%, 99%, and 99% concordance in results for the codons 790, 858, 861, and exon 19, respectively (Tables 11–14).



Appendix A: Setting Up therascreen EGFR Pyro Assays

In case the EGFR Plug-in Report has been installed, predefined Assay Setups for codons 719, 768, 790, and 858–861, and exon 19 deletions are available in the shortcut browser of the PyroMark Q24 software under the path "Example Files/PyroMark Setups/EGFR". The following steps do not need to be performed. The EGFR Plug-in Report can be obtained by e-mail from pyro.plugin@qiagen.com.

We strongly recommend the use of the EGFR Plug-in Report over manual analysis. Complex mutations cannot be added manually to a "Sequence to Analyze" and have to be analyzed using the plug-in. After installation of the plug-in or each time new software is installed or upgraded on the computer, the correct function of the plug-in should be verified as described in the EGFR Plug-In Quick Guide.

If the EGFR Plug-in Report has not been installed, the assay file must be set up manually before running the *therascreen* EGFR Pyro assay for the first time. Set up the assay for EGFR codon 719, codon 768, codon 790, codons 858–861, and exon 19 deletions by using the PyroMark Q24 Software, as described below.

Procedure

EGFR codon 719

- A1. Click in the toolbar and select "New AQ Assay".
- A2. Type the following sequence in "Sequence to Analyze".

 DGCTCCGGTGC

Note: The most frequent mutations in codon 719 will be detected in nucleotide 2155 using this "Sequence to Analyze".

The "Sequence to Analyze" can be changed after the run to analyze for mutations at nucleotide 2156. To check if mutations are present at nucleotide 2156, change the "Sequence to Analyze" to the following sequence.

GSCTCCGGTGC

Note: Ensure that the threshold for single peak height is set to 30 RLU. In addition, ensure that the heights of histogram bars are adjusted correctly (see instructions below).

A3. Manually enter the following "Dispensation Order".

ATGTCACTCGTG




Figure 16. Histogram for codon 719 (nucleotide 2155) with the "Sequence to Analyze" DGCTCCGGTGC. The red rectangle at the bottom of the bar at dispensation C5 illustrates the adjustment of heights of histogram bar.




Figure 17. Histogram for codon 719 (nucleotide 2156) with the "Sequence to Analyze" GSCTCCGGTGC. The red rectangle at the bottom of the bar at dispensation C5 illustrates the adjustment of heights of histogram bar.




Figure 18. Histogram for codon 768 (nucleotide 2303) with the "Sequence to Analyze" CAKCGTG.




Figure 19. Histogram for codon 790 (nucleotide 2369) with the "Sequence to Analyze" ATCAYGCAG. The red rectangle at the bottom of the bar at dispensation T8 illustrates the adjustment of heights of histogram bar.




Figure 20. Histogram for codons 858–861 with the "Sequence to Analyze" CKGGCCAAACDGCTGGGT.

and add squared brackets where the deletion starts and ends.

For the second most frequent deletion in exon 19 (2236del15), change "Sequence to Analyze" to the following.

A3. Manually add the following "Dispensation Order".

CTATCACTGTCAGCTCGATCGTCATCGTCACGC




Figure 21. Histogram for exon 19 del.

Note: The cap can be removed without disconnecting the tubing.

B5. If the vacuum workstation must be cleaned (for example, due to dust or spillage), follow the instructions in the *PyroMark Q24 User Manual*.
