Advance notice: Discontinuation of PyroMark® CE (IVD) products by February 28, 2027

Dear valued customer,

To help you prepare with clarity and confidence, we'd like to inform you that, in alignment with the requirements of the EU IVDR Regulation (EU) 2017/746 and subsequent amendments, no PyroMark CE (IVD) assay will be placed on the market after May 2026. Assays placed on the market before this date will continue to be supported until their expiration date. All other PyroMark CE (IVD) products will be discontinued by February 28, 2027.

We understand the important role these products play in your lab, and we're committed to supporting your work through this transition. Below are key milestones and details to help you plan ahead:

- The last PyroMark CE (IVD) *therascreen*® assays will be placed on the market by May 26, 2026. We anticipate that available stock will be depleted by the end of 2026.
