Procedure

Preparation of carrier RNA and addition of the internal control to the samples

Using the QIAsymphony DSP Virus/Pathogen Midi Kit in combination with the *artus* CT/NG QS-RGQ Kit requires introduction of the internal control (CT/NG RG IC) into the purification procedure to monitor the efficiency of sample preparation and downstream assay.

Internal controls must be added with carrier RNA (CARRIER)–Buffer AVE (AVE) mixture, and the total volume of the internal control–carrier RNA (CARRIER)–Buffer AVE (AVE) mixture remains 120 µl.

The table represents the addition of internal control to the isolation at a ratio of 0.1 μ l per 1 μ l elution volume. We recommend preparing fresh mixtures for each run just before use.

For internal control (IC) calculation, the "IC Calculator" within the QIAsymphony Management Console (QMC) should be used.

Loading of samples and controls

Make sure that the 2 controls (CT/NG Control CT+/NG– and CT/NG Control NG+/CT–) are located at the beginning of your samples in the QIAsymphony sample input. When preparing more than 69 samples, 2 additional controls must be available (see table below for an example). This is important because one PCR run contains 72 reactions (69 samples + 2 controls in the sample prep modules and 1 NTC in the assay setup module). When testing more than 69 samples, a second PCR run will be pipetted by the AS module automatically. To ensure that this run is valid, 2 controls must be in PCR positions 1 and 2. Therefore make sure that the 2 controls for the sample prep are always at the beginning of the Rotor-Gene Q run. When testing more than 45 samples, we recommend to split the samples into 2 batches on the AS module and, correspondingly, into 2 separate runs on the Rotor-Gene Q MDx 5plex HRM instrument. For more information see the 2 tables below. Please keep in mind that the NTC is processed by the AS module but not by the SP module.

Note: We do not recommend changing the number of NTC replicates manually. Rotor-Gene AssayManager will reject the run if the number of NTC replicates is changed.

Distribution of samples and controls (example for 96 reactions)

After each set of samples (1–71 and 72–96) the AS module will add a NTC sample (No Template Control).

The recommended workflow for 96 samples (including controls) is shown in the table below. In this example 2 x 46 samples (+ 2 controls) will be processed in 2 AS batches and 2 PCR runs. The first PCR run, with 46 samples, 2 controls, and 1 NTC, is finished while SP batches 3 and 4 are being processed.

Real-time PCR on the Rotor-Gene Q MDx 5plex HRM*

The *artus* CT/NG QS-RGQ Kit can be run on the Rotor-Gene Q MDx 5plex HRM instrument using manual analysis with Rotor-Gene Q software 2.1 or higher or using automatic analysis with Rotor-Gene AssayManager[®]. The following sections describe the settings and setup using the 2 different software packages.

Prepare the rotor for the run on the Rotor-Gene Q MDx 5plex HRM instrument:

- Place a 72-Well Rotor on the Rotor Holder.
- Fill the rotor with strip tubes. Make sure to start at position 1 and to fill the strip tubes in the correct orientation.
- Use empty capped strip tubes to fill all unused positions.
- Attach the locking ring.
- Load the Rotor-Gene Q MDx 5plex HRM instrument with the rotor and locking ring.

Real-time PCR using Rotor-Gene AssayManager

For automatic analysis using the *artus* CT/NG QS-RGQ Kit with Rotor-Gene AssayManager, the *artus* Basic pluginV1.0.3 (available for download from <u>www.qiagen.com/shop/automated-solutions/accessories/rotor-gene-assayManager</u>) must be installed to your Rotor-Gene AssayManager.

Start the installation process by double-clicking the ArtusBasic.Installation.msi file, and follow the installation instructions. For a detailed description, refer to "Installing Plug-ins" in the *Rotor-Gene AssayManager Core Application User Manual*.

To use the assay profile artus_CTNG_sample400_QS (short name: CTNG_a) with the *artus* CT/NG QS-RGQ Kit, the file AP_artus_CTNG_sample400_QS_V2_0_0.iap (available for download from <u>www.qiagen.com/products/artusctngqsrqqkitce</u>) must be imported to Rotor-Gene AssayManager.

To import the assay profile into Rotor-Gene AssayManager:

- 1. Navigate to the "Configuration Environment" and change to the "Assay Profile" tab.
- 2. Click "Import" and select the AP_artus_CTNG_sample400_QS_V2_0_0.iap file in the open file dialog.
- 3. Click "Open", and the profile is loaded and added to the list of available assay profiles.

Note: The same version of an assay profile cannot be imported twice.

^{*} If applicable, Rotor-Gene Q 5plex HRM instrument with a production date of January 2010 or later. The production date can be obtained from the serial number on the back of the instrument. The serial number is in the format "mmyynnn" where "mm" indicates the production month in digits, "yy" indicates the last two digits of the production year, and "nnn" indicates the unique instrument identifier.

Starting a run using Rotor-Gene AssayManager

After installing the plug-in and importing the assay profile, Rotor-Gene AssayManager can use the information given in the QIAsymphony AS result file to set up a run for real-time PCR amplification and subsequent automatic interpretation of results.

QIAsymphony AS result files can either be downloaded using a USB stick or using the QIAsymphony Management Console. If the QIAsymphony AS result file is downloaded using a USB stick, it is stored in .zip format in the folder x:\Log\results\AS.

Note: Before importing the QIAsymphony AS result file the .zip file needs to be extracted. If the QIAsymphony AS result file is transferred using the QIAsymphony Management Console (QMC), this step is not required.

To perform a PCR run:

- 1. Start Rotor-Gene AssayManager.
- 2. Change to the "Setup" environment and select the source "QIAsymphony" as "Import type". In the "Select file" dialog, open the corresponding QIAsymphony AS result file and click "Open". The work list is then added to the list of available work lists.
- 3. The run can be started from the "Available work lists" table by clicking "Apply" in the button bar in the appropriate work list entry (Insert naming of imported QS worklists).
- 4. Enter an experiment name.
- 5. Select a cycler and confirm that the locking ring is attached.
- 6. Click the green "Start run" button.

Finishing and releasing a run

To see the progress of the run, change to the corresponding cycler screen. When the run is finished, click "Finish run" to release the cycler and to approve the sample in the "Approval" environment.

- 7. Select the "Approval" environment.
- 8. Click "Apply filter" (or choose own filter options beforehand).
- 9. Select experiment.
- 10. Click "Start approval".
- 11. Approve the results of each test sample: Use the "Accepted" button for test samples whose results analyzed by Rotor-Gene AssayManager you agree with. Use the "Rejected" button if the test sample result evaluated by Rotor-Gene AssayManager is not acceptable for any reason.

Note: A result automatically set to "Invalid" by Rotor-Gene AssayManager cannot be converted to a valid result anymore, even if the result is rejected.

- 12. Click "Release /report data ... "
- 13. Choose a report profile and click "OK". The report will be generated and stored automatically.

Note: The user needs approval rights to approve a run.

14. Unload the Rotor-Gene Q MDx 5plex HRM instrument and discard the strip tubes according to your local safety regulations.

Interpretation of results using Rotor-Gene AssayManager

The *artus* CT/NG QS-RGQ AssayProfile for urine samples automatically sets the threshold and contains all rules for interpreting the assay results automatically. Based on these, the software will assess the validity or invalidity of samples and controls. This automatic analysis may provide the following corresponding flags.

IMPORTANT: A cut-off of 40 C_T is applied in the NG channel, which will produce an "INVALID" result with a flag of "CT_ABOVE_ACCEPTED_RANGE". The following instruction should be followed carefully.

- If NG is reported as invalid with the flag "CT_ABOVE_ACCEPTED_RANGE", and the IC is detected and valid, the sample can be treated as a valid NG-negative sample. No retest is required.
- If NG is reported as invalid with any other flag, the sample should be retested.

If CT is reported as invalid with any flag, the sample should be retested.

Examples of positive and negative PCR reactions

The *artus* CT/NG QS-RGQ Kit contains 2 controls to monitor the extraction procedure and the PCR: the CT/NG Control CT+/NG– and the CT/NG Control NG+/CT–. These controls are loaded on the QIAsymphony SP/AS and treated like the other samples. The internal control (CT/NG RG IC) is added to the sample during the DNA extraction process and is present in all samples and the NTC.

The controls are used in the PCR setup process and should produce specific results in the PCR similar to the results shown in the figures below.




Figure 1. Cycling Green: CT positive control. Results of a run with the CT/NG Control CT+/NG-.




Figure 2. Cycling Orange: NG positive control. Results of a run with the CT/NG Control NG+/CT-.




Figure 3. Cycling Yellow: internal control. Results of a run with the CT/NG RG IC.

If one of the controls or the corresponding IC signal fails, the run must be rated as invalid.

Limitations

A study was conducted to assess the performance of the *artus* CT/NG QS-RGQ Kit with samples containing high concentrations of CT or NG in the presence of the other pathogen in low copy numbers. The results are shown in the table below.
