Candidate Data Privacy Constents



While applying to QIAGEN you will be asked to provide a consent to the following Data Privacy Statements:

• JOB CONSENT (mandatory):

You can give a consent to be considered only in selection process for particular job opening and you will not join QIAGEN Candidate Pool. You will not be available for sourcing and you will not be linked to any other job.

If you change your mind and want to give consent for Candidate Pool (Database), you can do that over My Candidate Portal.

If you no longer have the application confirmation e-mail with My Candidate Portal access link, you can join QIAGEN Candidate Pool by using Join the QIAGEN Talent Pool application in our <u>career site</u>.

CANDIDATE POOL CONSENT (optional):

You can give a consent to be considered for all job openings in QIAGEN.

You need to provide minimum JOB CONSENT – otherwise we will not be able to consider you as a candidate.
